## Explanation

Acting in accordance with the provision of Article 17, paragraph 3 of the Law on Registration Procedure in the Agency for Economic Registry, by submitting a unique registration application for the establishment of legal entities and other entities and registration in the single taxpayer registry number No. BP 53228/2017, on May 25, 2017 The Applicant retained the right of decision-making on this application, based on the filing of an application that was rejected by the Decision of the Registrar BP 51823/2017 dated 23 May 2017, as it was established that the conditions from Article 14, paragraph 1, point 8 of the same Act were not fulfilled.

By checking the fulfilment of the conditions for registration, stipulated by the provision of Article 14 of the Law on the registration procedure in the Business Registers Agency, the Registrar has determined that the conditions for registration have been met, so he decided as in a dispute decision, in accordance with the provision of Article 16 of the Law.

The amount of the fee for conducting the registration procedure was determined by the Decision on fees for registration and other services provided by the Agency for Business Registers ("Official Gazette of the Republic of Serbia", No. 119/2013, 138/2014, 45/2015 and 106/2015).

**INSTRUCTIONS ON JURISDICTION:** An appeal against this decision may be made to the Minister in charge of the position of companies and other forms of business, within 30 days from the date of publication on the website of the Business Registers Agency, and through the Agency.

### NOTICE:

Attached to this decision is the certificate on the allocation of the tax identification number (PIB) and the certificate on the application for compulsory social security.

If you do not find the attached certificate in the attachment of the solution, you are required to do the following:

1. To contact the Tax Administration for the VAT,

To personally submit a unique application for compulsory social security, NOW upon receipt of this notice, ONLY IF YOU STARTED THE BEGINNING OF ACTIVITY, at one of the counters of any organizational unit of the mandatory social security organization (the Republican Pension and Disability Insurance Fund, the Republic Institute for Health insurance, National Employment Service) or through the portal of the Central Registry of Compulsory Social Security, if you have not already been registered for insurance based on the work and only if you have registered the beginning of the activity.
